This contract is between Georgia Ives, referred to as seller, and _____, referred to as buyer.

Purchaser Agrees to the Following:

1. The purchaser accepts full responsibility of the well-being of the kitten and must be able to provide for its welfare.
2. This kitten is registered as a: Pet___ Breeder___ Show:___
3. The purchaser agrees that this kitten will be spayed/neutered **before** 7 months of age unless purchasing breeding rights with the kitten.
4. The purchaser guarantees that the kitten will not be used for breeding or stud, unless purchasing breeding rights with the kitten.
5. The purchaser agrees to never declaw the cat.

General Terms and Conditions:

- Under this contract, ownership of the kitten is transferred from the Breeder to the Purchaser;
- Transport costs and risks are not the responsibility of the seller.
- The kitten is guaranteed to be in good health (with "good health" meaning that the kitten is free from illnesses and faults noticed by the purchaser or breeder and by the breeder's veterinarian);
- It is the purchaser's responsibility to provide immediate veterinary care should the kitten show any signs of illness or distress; failure to do so shall render the health guarantee null and void.
- If the kitten is found to be medically deficient by the purchaser's veterinarian within 7 days of the transfer of ownership with an untreatable or life threatening problem of PKD/HKM problems, it **MUST** be reported to the seller immediately. The kitten may be kept and refunded, or returned and replaced with another kitten of equal value. If no kitten is available at that time, the seller will offer one from the next litter. The kitten cannot be returned after the 7 day period and/or if it has been exposed to another cat which is not currently vaccinated.
- The breeder guarantees that the kitten has been currently vaccinated and treated for worms/fleas at the time of transfer.

- This kitten HAS NOT been vaccinated for rabies.

***Addendum:**

The kitten is guaranteed against HCM & PKD until 1 year of age. The kitten will be replaced or refunded, at the discretion of the seller ONLY if an appropriate autopsy is performed by a licensed vet and proof of such diagnosis is provided by the veterinarian. Veterinary costs are not the responsibility of the breeder. A replacement will be made of a cat of comparable quality and value at the discretion of the breeder. In any case after 1 year of age this guarantee does not apply.

Breeding Agreements:

- If the kitten is sold with breeding rights: If the cat is found to have genetic defects which prevent it from being used for breeding, the seller agrees to immediately refund or replace the kitten as soon as possible. Infertility is defined as when the cat is more than 1 years of age and has been unsuccessfully bred at least three times with a proven stud/queen. This must be certified by a veterinarian-signed document of infertility.
- Female cats are not replaced/refunded for pyometra.

Both breeder and purchaser consider this contract to be legal and binding.
